**THIS MATTER** having come before the Board upon its own motion, and the Board having reviewed the file herein and being otherwise advised in the premises;


**IT IS THEREFORE HEREBY ORDERED** Petitioner shall have until **October 8, 2010**, and the Department of Revenue shall have until **October 25, 2010**, to file their preliminary statements.

Pursuant to *Rules Chapter 2 § 10, State Board of Equalization*, each party shall file with the Board (**original and four copies**) and serve on all other parties, the preliminary statement setting forth:

1. A brief summary of the contentions of the parties;
2. Significant, uncontroverted facts about which there is no genuine issue which may be established by admission or stipulation;
3. Contested issues of fact;
4. Contested issues of law (a party may include memorandum on significant legal issues at their option);
5. The amount of the tax assessment or refund denial, and the amount of tax in controversy;
6. An estimate of the time required for the hearing.




