**IT IS THEREFORE HEREBY ORDERED** the prehearing and hearing dates set in this matter are **vacated** and **reset** as follows;


The prehearing in this matter shall commence at 9:00 a.m. on May 5, 2011 in Room 1722, Herschler Building, Cheyenne, Wyoming;
