**THIS MATTER** having come before the Board upon it's own motion and the Board having held a hearing in this matter on January 24, 2012, and having set the following deadline at the end of the hearing, and having reviewed the file herein and being otherwise fully advised in the premises:

**IT IS ORDERED** the parties shall simultaneously file Closing Arguments, as well as Proposed Findings of Fact and Conclusions of Law on or before **February 24, 2012**.

**IT IS FURTHER ORDERED** Any and all proposed findings of fact must be referenced to the record, with a transcript page and line reference and/or an exhibit reference. Any proposed finding of fact not referenced to the record will be disregarded and not considered by the Board. Likewise any conclusions of law must state the legal authority upon which the conclusion is based. Any conclusion of law not referenced with supporting legal authority will be disregarded and not considered by the Board.

**IT IS FURTHER ORDERED** the parties are ordered to submit copies of all legislative history and any other authority cited during the hearing and in briefs, including any State Board of Equalization opinions.


