ORDER OF DISMISSAL WITH PREJUDICE

THIS MATTER came before the State Board of Equalization (Board) on its Notice of Intent to Dismiss with Prejudice, issued January 14, 2015, and the Board having reviewed the file herein and being otherwise advised in the premises finding as follows;

A. The Mineral Tax Division, Department of Revenue, by letters dated December 3, 2014, notified Anadarko E&P Company LP of take-in-kind notices for 2011 gas production;

B. Pursuant to the provisions of Chapter 2, Section 5(e), Rules, Wyoming State Board of Equalization, appeals and objections to final administrative decisions of the Department must be filed with the State Board within thirty days of the final administrative action;

C. The notices issued by the Mineral Tax Division, Department of Revenue, are a final administrative action;

D. The notice of appeal by Anadarko E&P Company LP was docketed effective January 7, 2015;

E. The appeal of Anadarko E&P Company LP was not timely filed, the same being due January 2, 2015, and as a result this Board is without jurisdiction herein.

IT IS ORDERED this matter shall be and the same is **dismissed with prejudice**.
