**THIS MATTER** came before the State Board of Equalization (Board) on its own motion, and the Board having reviewed the file herein and being otherwise advised in the premises finds as follows;

A. The Mineral Tax Division, Department of Revenue, by letter dated December 2, 2014, notified Kerr McGee Oil & Gas Onshore LP of take-in-kind notices for 2011 gas production;

B. Pursuant to the provisions of Chapter 2, Section 5(e), Rules, Wyoming State Board of Equalization, appeals and objections to final administrative decisions of the Department must be filed with the State Board within thirty days of the final administrative action;

C. The letter issued by the Mineral Tax Division, Department of Revenue, is a final administrative action;

D. The notice of appeal by Kerr McGee Oil & Gas Onshore LP was docketed effective January 7, 2015;

E. The appeal of Anadarko E&P Company LP was not timely filed, the same being due January 2, 2015, and as a result this Board is without jurisdiction herein.

**NOTICE IS HEREBY GIVEN** this matter shall be dismissed with prejudice on or after **January 29, 2015**, unless Petitioner or the Department file specific written objections to dismissal before said date.
