- 1. The Mineral Tax Division, Department of Revenue, by notice dated January 25, 2016, notified Lance Oil & Gas Company, Inc. (Petitioner) of a volume discrepancy in take-in-kind production reporting for the 2012 production year on reporting group 059071;
- 2. Pursuant to the provisions of Chapter 2, Section 5(e), Rules, Wyoming State Board of Equalization, appeals and objections to final administrative decisions of the Department must be filed with the State Board within thirty (30) days of the final administrative action;
- 3. The volume discrepancy notice issued by the Mineral Tax Division, Department of Revenue, is a final administrative action. Therefore, Petitioner was required to appeal on or before February 24, 2016;
- 4. Petitioner's Notice of Appeal was docketed effective February 25, 2016, evidenced by the postmark on the envelope containing the appeal documents;
