- A. All discovery shall be completed on or before **September 12, 2016**;

The parties shall exchange complete copies of proposed exhibits marked as appropriate 100 through 199 by Petitioner, and 500 through 599 by the Department, and identify the names and address with a brief description of expected testimony of each possible witness including any expert witness, and shall designate all confidential exhibits and potential confidential testimony not later than **September 26, 2016**;

IT IS FURTHER ORDERED all other provisions of the State Board's June 1, 2016, Hearing Order remain in full force and effect.
