A. All discovery shall be completed on or before **December 23, 2016**;


B. The parties shall exchange complete copies of proposed exhibits marked as appropriate 100 through 199 by Petitioner, and 500 through 599 by the Department, and identify the names and address with a brief description of expected testimony of each possible witness including any expert witness, and shall designate all confidential exhibits and potential confidential testimony not later than **January 9, 2017**;

**IT IS FURTHER ORDERED** all other provisions of the Board's August 22, 2016, Hearing Order remain in full force and effect.


