ORDER OF DISMISSAL WITH PREJUDICE


THIS MATTER came before the State Board of Equalization (State Board) on its own motion. The State Board, having reviewed the file herein and being otherwise advised in the premises, finds as follows:

1. The Mineral Tax Division, Department of Revenue (Department), by letter dated January 25, 2021, notified EOG Resources (Petitioner) that Wyoming severance tax was due.
2. Pursuant to the provisions of Chapter 2, section 5(e), Rules, Wyoming State Board of Equalization, appeals and objections to final administrative decisions of the Department must be filed with the State Board within 30 days of the final administrative action;
3. The letter issued by the Department of Revenue is a final administrative action. Therefore, Petitioner had until February 24, 2021 to file an appeal with the State Board;
4. Petitioner's Notice of Appeal was filed and docketed effective February 25, 2021, the date evidenced by the file stamp by personal delivery;
5. Petitioner's appeal was not timely filed, therefore, the State Board lacks jurisdiction to proceed.

NOW, THEREFORE, IT IS ORDERED this matter is **dismissed with prejudice**.


