**ORDER OF DISMISSAL WITH PREJUDICE**

**THIS MATTER** came before the State Board of Equalization on its own motion. The State Board, having reviewed the file herein and being otherwise advised in the premises, finds as follows:

1. Petitioner, Jarel Cellmer, appealed to the State Board from the Natrona County Board of Equalization’s decision in his property tax appeal;
2. The State Board issued a Briefing Order giving Mr. Cellmer until July 1, 2021 to file his opening brief;
3. Mr. Cellmer did not file his opening brief by July 1, 2021, nor did he file one at all;
4. The State Board issued an Order to Parties Regarding Joinder of Similar Appeals. Mr. Cellmer had until July 21, 2021 to sign that order to Join Mr. Harmon’s appeal.
5. Mr. Cellmer did not reply to the Order to Join Mr. Harmon’s appeal.
6. The State Board issued a Notice of Intent to Dismiss giving Mr. Cellmer until August 18, 2021 to object to the dismissal of his appeal;
7. Mr. Cellmer did not respond to the Notice of Intent to Dismiss.

**IT IS, THEREFORE, ORDERED** that this matter is dismissed with prejudice.
